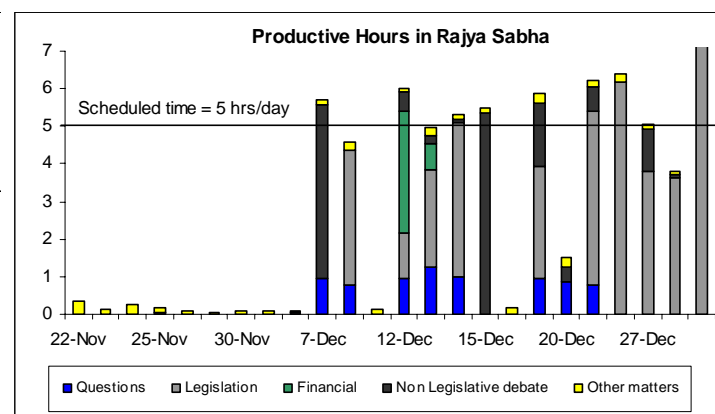
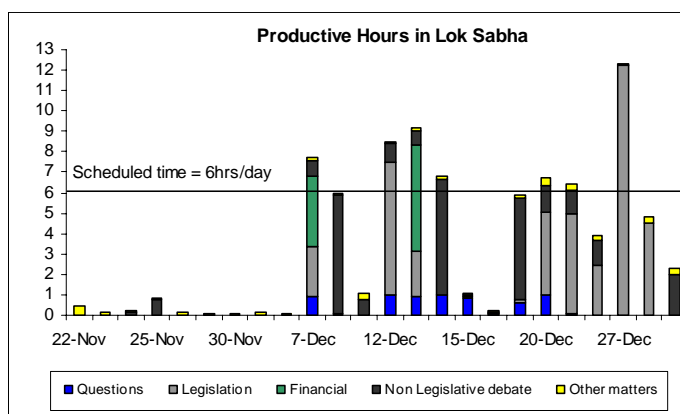


Plan vs. Performance

The Lok Sabha and Rajya Sabha adjourned *sine die* on December 29. Issues related to inflation, agrarian crises, Lokpal and exploitation of river Ganga and Himalaya were discussed besides supplementary demands for grants and legislative Bills. Sittings of both the Houses were extended by 3 days to discuss some key Bills including Lokpal and Lokayuktas Bill. 28 legislative Bills were introduced and 15 Bills were passed other than two Appropriation Bills during the session. Two Bills were withdrawn and replaced by new Bills and one Bill was negatived. Several hours were lost due to interruptions on the issues of inflation, black money, Telangana, FDI in retail and Mullaperiyar dam. Lok Sabha worked for 59% of the scheduled hours and Rajya Sabha for 62%.
